The release of 3rd instalment (40%) of SAAP is based on the utilization of total minimum of 75% of the overall release (SAAP-I, II & III). As per the OM K-16015/2018-AMRUT-1B dated 06.02.2018, a set of documents are required for the release of 3rd instalment of Central assistance under SAAPs. MoHUA had released an amount of Rs.57.6 Cr., Rs.77.28 Cr. & Rs.97.36 Cr. against SAAP-I, II & III respectively with a total Central share of Rs.232.24 Cr. to all SAAPs. As per OM K-16015/22/2017-AMRUT-1B dated 28.08.2019, 2nd instalment of SAAP-I, II & III (40% of awarded works) Rs.194.74 Cr. was released by Government of India. Agenda Item No.4: INDEPENDENT REVIEW AND MONITORING AGENCY (IRMA) – REVIEW OF QUARTERLY PROGRESS REPORTS 1,2,3 AND OBSERVATIONS/COMMENTS IN THE REPORT SUBMITTED.

Ministry of Housing and Urban Affairs Department selected M/s WAPCOS Ltd, Gurugram as Independent Review and Monitoring Agency (IRMA) for AMRUT Mission, Kerala. The agreement with IRMA was executed on 1st March 2019. The Scope of Services carried out by IRMA is to monitor all Projects in all the stages of project execution and timely reporting to State Government and Central Ministry about their observations regarding the implementation of projects in different stages, such as pre- construction stage, construction stage, commissioning, trial run and testing stage and post construction stage. IRMA has submitted one initial fact-finding report and three quarterly progress reports till date.

IRMA observed in their initial fact-finding report submitted on 25th May 2019 that, “there appears to be a lack of expertise in Septage & Sewerage sector and might require strong technical support. The Septage & Sewerage projects are the most challenging and time consuming considering the various obstacles in the field and therefore need close attention and monitoring”. The Independent Review and Monitoring Agency (IRMA) also suggested in their 1st quarterly report submitted on 26th September 2019, “that “State Mission Management Unit may consider to constitute a team of experts to help the implementing agencies for the execution of projects under Septage and Sewerage sector if experts are not available with them”. There are also comments regarding the lack of expertise of ULB engineers in Sewerage & Septage Management sector in second and third quarterly reports.

Septage and Sewerage Management is one of the priority sectors under AMRUT Mission. Presently, there are 19 projects amounting to Rs.426.35Cr in Sewerage (11 projects amounting Rs.402.3Cr) and Septage (8 projects amounting Rs.23.7Cr) sector which are directly to be executed by ULBs on which tendering and awarding are in progress. The ULB engineering wing have no previous experience and are not familiar with the on-site implementation method of Septage and Sewerage projects which are piloted in their mission cities. They have raised their concerns to Deputy Mission Director during his city visits and in the Project Review Meetings of AMRUT conducted by Mission Director, about the lack of specific experience and the project management methods to be adopted in the fields of supervision and execution of Sewerage & Septage Projects.

Hence it is suggested to appoint a panel of Experts including experts of Environmental, Mechanical and Electrical Engineers to provide technical expertise and assistance to ULB engineers. They can be sourced through Institution of Electrical Engineers (IEE), Kerala Water Authority Engineers Association, Retired Officials from CET or from other reputed institutions for effective project management support in the case of Sewerage and Septage projects undertaken by the ULB Engineering wing. We can also try to get experts who are retired from Sewerage boards of Karnataka, Tamilnadu and Andhra Pradesh. The selected panel of experts have to deliver handholding support to ULB engineers for the effective implementation of



Septage and Sewerage projects right from start upto completion and operation of all projects under the sector.

It is suggested that remuneration for the selected experts in the panel can be on per diem basis of Rs. 3000-8000 (based on experience) per visit plus travel expense, expenses of boarding and lodging. The visits are to be scheduled based on the need of the ULB in various stages of execution. Their expertise can also be made use for any revision of proposals/technology. They can also be used for checking of DPR, assisting the technical committee in issue of TS, tendering works, scrutiny of bids and supervision for Septage/Sewerage Treatment Plants.

Decision taken:

1. The Committee took note of the comments/ observations in the quarterly progress report submitted by IRMA
2. The Committee agreed with the suggestions on appointment of a panel of experts and their remuneration, as given above by SMMU, for assisting the ULB Engineers as and when it is required. (Action: Principal Secretary, LSGD (Urban) and Mission Director, AMRUT)

Agenda Item No.5: RELEASE OF DEDUCTED SALARY OF CMMU OFFICIALS IN AMRUT

In the 13th State Level High Powered Steering Committee (SHPSC) meeting held on 14.12.2017(*Annexure-2*), the Principal Secretary, LSGD issued a revised deadline for completion of DPRs of all projects except KWA by 15.01.2018, a failure wherein will lead a deduction of 20% from the salaries of the staff of SMMU and CMMUs.

Based on this decision, 20% deduction was affected for 24 contract staffs of CMMU from the month of January 2018 and still continuing.

The last AS was approved in the 20th SHPSC dtd 11.12.2018 and there are no DPRs for approval from the approved SAAP.

The affected staffs are continuously requesting for release of the deducted salary, since all the DPRs have been approved.

Decision taken: SHPSC approved to release the withheld amount to the affected officials in CMMU.

The tender was initially published on 18.5.19 with the closing date as 20.6.19 and there was no response. Hence the project was retendered on 10.7.19 with the closing date as 30.7.19. The closing date was extended 5 times till 5.10.2019, due to no response. Then two bidders had submitted their bids in the retender. The lowest bidder had quoted for 53.27% excess for package A and 54.17% excess for package B and the same was placed before 23rd SHPSC. The SHPSC directed to retender the work as the rates quoted by the Contractors were high. The project was re tendered nationwide as two packages on 20.02.2020.

Decentralized Sewerage System for Zone-A (Package A):



The work in Package A costs Rs.59.77 Cr., comprises providing, laying, testing & commissioning of 48 Km underground DWC HDPE Sewerage Pipes of various diameters (200mm, 250mm, 300mm, 350 mm, 400mm, 600 mm) at a depth varying from 1.5 m to 4.5 m. Construction of a sewage pumping station including mechanical, electrical and instrumentation works. Basic and detailed engineering including procurement, construction, testing, commissioning, of Sewage Treatment Plant (STP) -7 MLD to treat Municipal Sewage Wastewater & Operation and Maintenance of the whole system for 5years.

The project was retendered on 20.02.2020 and only one bid was received, from M/s Midland Engineering and Contracting Company Pvt Ltd, Malappuram in JV with DNP Infrastructure Pvt. Ltd (they were the same L1 in previous bid).

The technical bid was opened on 30.03.2020 and as the same bidder was declared technically qualified by the technical committee on 28.10.2019, during the evaluation of bidders in the 1st retender, further technical evaluation was not done by the ULB. Subsequently the financial bid was opened on 16.05.2020 and the quote after negotiation are as below,

- Estimated Cost- Rs. 59.77Cr.
- Quoted cost by the bidder-Rs.93.93 Cr
- Negotiated Amount- Rs. 91.36Cr.
- O&M for 5 years-Rs.30.52 Cr

- **Excess Amount- Rs.31.59Cr.(52.85%)** (Previous tender excess was 53.27% which was decided as high by 23rd SHPSC)

Decentralized Sewerage System for Zone-A (Package B):

The work in Package B costs Rs.56.38 Cr., comprises providing, laying, testing & commissioning of 50 Km underground DWC HDPE Sewerage Pipes of various diameters (200mm, 250mm, 300mm, 400mm, 600 mm) in a depth varies from 1.5 m to 4.5 m. Construction of a sewage pumping station including mechanical, electrical and instrumentation works. Basic and detailed engineering including procurement, construction, testing, commissioning, Sewage Treatment Plant (STP) -6MLD to treat Municipal Sewage Wastewater & Operation and Maintenance of the whole system for 5years. The project was retendered 20.02.2020 and only one bid received, Midland Engineering and Contracting Company Pvt Ltd, Malappuram in JV with DNP Infrastructure Pvt. Ltd had submitted their bid in the retender.

The project was retendered on 20.02.2020 and only one bid was received, from M/s. Midland Engineering and Contracting Company Pvt Ltd, Malappuram in JV with DNP Infrastructure Pvt. Ltd (they were the same L1 in previous bid).

The technical bid was opened on 30.03.2020 and as the same bidder was declared technically qualified by the technical committee on 28.10.2019, during the evaluation of bidders in the 1st retender, further technical evaluation was not done by the ULB. Subsequently the financial bid was opened on 16.05.2020 and the quote after negotiation are as below,



- Estimated cost- Rs. 56.38Cr.
- Quoted cost by the bidder-89.11Cr.
- Negotiated Amount- Rs. 86.91Cr.
- O&M for 5 years-Rs.25.94Cr
- Cost of contingencies and utility shifting-Rs.17,68,105/
- **Excess Amount- Rs.30.53Cr. (54.15%)** (*Previous tender excess was 54.17% which was decided as high by 23rd SHPSC*)

Total Excess Amount: Rs 62.12Cr.

Revised AS Amount requested – Rs. 178.62Cr.

Council decision: EG21/61457/17 dated 20.05.2020 (Annexure –10)

Observations of SMMU:

- In 23rd SHPSC, SMMU had worked out the comparison of market rates for labour and materials of the various components of work and noted that estimate as per market rate is about 11.93 % compared to 53.27% excess quoted for package A and 13.06% against 54.17% quoted for package B.
- Only one bid has been received and the bidder is same who quoted as L1 in the previous tender.
- There is not much reduction in the present quote compared to previous quote. Package A- 52.82% excess(53.27% previously). Package B-54.15% excess(54.17% previously)
- There is no savings in AMRUT for Kozhikode City to meet the additional financial commitment to the tune of Rs. 62.27Cr. + Rs. 10Cr. (Revised AS Amount).
- vide No.14/2015/AMRUT/Kozhikode dated 21.01.2020, SMMU (Annexure-11) had submitted detailed report to Additional Chief Secretary, LSGD with the following recommendations:

- Re tender the works to get a better rate.
- Splitting the works as 1) STP and 2) Networks with ancillary works.
- STP Construction can be started first to ensure that plant work progresses and then network portions can be tendered to avoid purchase of pipes in beginning itself or just laying of pipes alone happening.



- Vide letter No.14/2015/AMRUT/Kozhikode dated 23.01.2020, SMMU (*Annexure-12*) had informed to Secretary, Kozhikode the above recommendations (However the works have been again retendered on 20.02.2020 without splitting STP and networks separate).
- Secretary has also reported that 23 councillors have raised objections (*Annexure-13*) in awarding these works at such high rates.

Considering the above SMMU recommends to SHPSC the following:

- Re-tender the works to get a better rate.
- Splitting the works as 1) STP and 2) Networks with ancillary works.
- STP Construction can be started first to ensure that plant work progresses and then network portions can be tendered to avoid purchase of pipes in beginning itself or just laying of pipes alone happening.

Deliberations done: Mission Director explained in detail the reasons why the quoted rate is seen to be high as follows:

- This is an item rate tender. So, scrutiny and negotiation should be based on high and illogically quoted items.
- There are 417 items in Package A and 390 items in Package B.
- Exorbitantly high quoted rates are for 15 items in Package A and 19 items in Package B.
- These high quoted rates are for pipes and pre-fabricated man holes. 3rd item is for trenchless (HDD- Horizontal Directional Drilling) technology and is notional.
- Total network length for Package A is 48 Km. and Package B is 50 Km.
- Most significant high quoted rate is for **200mm dia pipes**

- **Package A:**

- 43970m @ 290 % above estimates
- LMR only 17.55 % above estimate.
- Cost excess above estimate is 24.07 Cr.

- **Package B:**

- 44319m @ 290% above estimate
- LMR is only 17.55 % above estimate
- Cost excess above estimate is 24.26 Cr.



- The Market rate for 200mm dia pipe is 1170+GST = 1310/- (Mahaveer Trading Corporation- given by KWA)
- KWA rate for supply of 200mm dia pipe is only 1237+GST= 1385/-
- KWA rate for the supply of items and laying 200mm dia pipe is 1698/-, the estimate cost is 1888.38/-
- LMR is 2219.76/- but quoted rate is 7363/- and has no justification to accept the same
- **Package A:**
 - Total negotiated quoted amount is 91.36 Cr.
 - If we allow market rates for the 15 major excess quoted items, the maximum allowable amount shall be 62.87 Cr.
 - % Excess payable above estimate comes to 5.19%
- **Package B:**
 - Total negotiated quoted amount is 86.91 Cr.
 - If we allow market rates for the 19 major excess quoted items, the maximum allowable amount shall be 57 Cr.
 - % Excess payable above estimate comes to 1.10%

Decision taken: SHPSC directed the Secretary, Kozhikode Corporation to negotiate again with the Contractor based on the above deliberations and a detailed rate analysis has to be obtained from the contractor on the items quoted with rates much higher than the local market rate.

Based on the negotiation and justification of the high rate from the contractor, the Corporation should submit a comparison statement with justification and the matter should be placed before the SHPSC. (Action: Secretary, Kozhikode Corporation)


