### ORDER

As per the order read as 1st paper above, validity of Administrative Sanctions issued to various Civil works are for three years.

2. As per the letter read as 3rd paper above the Mission Director, AMRUT has informed that the AMRUT projects are in final stage and most of the projects had been issued AS three years back and their AS is to be revalidated.

3. The request to extend the validation of Administrative Sanctions (AS) of all works up to the mission period was placed before the 26th State High Power Screening Committee (SHPSC) and the 26th SHPSC directed the Principal Secretary (Urban) to conduct an evaluation of all projects that requires validation of AS to confirm if projects that do not have possibility to start may be decided to be dropped.

4. Later the status of projects, for which AS was accorded 3 years back has been evaluated by the 20th SLTC and Committee decided to recommend the revalidation to SHPSC and the matter was placed before the 27th SHPSC and as per the Minutes read as 2nd paper above, the Committee vide decision No.5.2 approved the revalidation of AS of projects for which AS was accorded 3 years ago.

5. Government have examined the matter in detail and based on the decision of 27th SHPSC, are pleased to revalidate the G.O.s listed below, that were issued 3 years ago, upto the Mission period.
