ORDER

As per the letter read as 2nd paper above, the Mission Director informed that the Secretary, Kochi Corporation has submitted a proposal for the revision of Administrative sanction for five UT works detailed below,“(SAAP 2017-18 & 2016-17 sector), being implemented by the Kochi Corporation through KMRL, before the 26th SHPSC. The Committee directed Principal Secretary (Urban), LSGD to examine the rationale in executing the additional works in detail. The Secretary, Kochi Corporation reported that the works were tendered by the KMRL after clubbing 5 to 6 works as one package.

2. The total cost of each package after execution is well within the total AS of all works in that package. Hence there is no additional financial commitment. The action was approved by the Kochi Corporation Council.

3. The matter was reviewed by the 20th SLTC meeting and decided to recommend the action taken by Kochi Corporation in executing the additional works for ratification, including revision of AS to SHPSC. The excess amount can be met from the savings of other works in the same package. The 27th State Level High Powered Steering Committee ratified the action taken by Kochi Corporation and decided to accord revised AS for the Urban Transport works.

4. Government have examined the matter in detail and based on the decision of the 27th SHPSC, pleased to ratify the action taken by Kochi

Corporation and also to accord revised Administrative Sanction for the Urban Transport works detailed below:


