

Minutes of the Meeting of the Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 held under the Chairmanship of Secretary (HUA) on 16.03.2022 from 03:15 PM to 04:30 PM

The Additional Secretary and National Mission Director (AMRUT) welcomed Secretary (Housing and Urban Affairs), other Members of the Apex Committee and participating officers from State/ UT Governments. She initiated the discussion on agenda of the meeting through detailed presentation on each item of the agenda. The List of Participants is at Annexure-A.

Agenda-wise discussion held in the meeting and its outcome and decision taken thereon by the Apex Committee are stated in following paragraphs.

1. Approval of first tranche of State Water Action Plans (SWAPs) submitted by the following States under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0:

Decision:

- i) Apex Committee approved the SWAP of all the above States.
- ii) Chairman, Apex Committee directed to have a certain benchmark for threshold for unspent balance in State Nodal Account (SNA) for further funds to be released under AMRUT 2.0.
- iii) Accordingly, State of Tamil Nadu and Uttar Pradesh are to submit Utilisation Certificates of at least Rs.400 Crore and Rs.300 Crore respectively to become eligible for release of 1st instalment of CA against SWAP 1 under AMRUT 2.0.

2. Integration of erstwhile scheme of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) under AMRUT 2.0

Decision: Apex Committee was apprised of that erstwhile scheme of AMRUT will be subsumed under the under AMRUT 2.0, with provisioning of Rs.10,000/- crore as Central Share for ongoing already approved projects under AMRUT. The Mission will be supported upto 31st March 2023.

3. Progress in implementation of erstwhile scheme of AMRUT

Decision: Apex Committee desired that all undergoing projects under AMRUT should be completed by 31.03.2023.

4. SAAP revision of Puducherry

Against the approved SAAP size of Rs. 64.91 Crore for the UT of Puducherry under AMRUT1.0, three projects worth ₹16.08 crore could not be grounded due to failed tenders. Thereafter, the bid placed in the last call was stated to be abnormally high. As such SHPSC decided to drop these three projects and instead proposed taking two new projects in water supply sector amounting to ₹19.666 crore. Further, the approval accorded during the EFC meeting on JJM-U (Now called AMRUT 2.0), the Committee under point (6) (iii) stated that the AMRUT mission will be subsumed under the JJM-U (Now AMRUT 2.0) and provisioned for ₹ 10,000/- crore as Central Share for ongoing already approved projects under AMRUT for extended period after 2020-21 upto 31st March 2023 to fulfil the mission objectives.

Since the proposed projects are well within the limit of already approved SAAP size and are in the priority sector of water supply, a proposal was placed for concurrence of IFD to revise the SAAP of Puducherry as stated above. IFD concurred to the instant proposal subject to approval of the competent authority, overall SAAP size remaining with the approved limit of ₹64.91 crore and the UT confirming to complete the new projects within the extended period.

Accordingly, the SAAP of Puducherry was revised with the approval of Secretary (HUA) as proposed by the UT.

Decision: Apex Committee has approved the SAAP revision of Puducherry.

5. Release of 2nd/3rd instalment of committed Central Assistance (CA) to States/UT (Meghalaya, Uttar Pradesh, West Bengal, Haryana, Himachal Pradesh, Uttarakhand, Delhi, Tamil Nadu, Nagaland, Arunachal Pradesh, Kerala, Maharashtra, Jharkhand, Punjab, Sikkim, Tripura, Madhya Pradesh, Jammu & Kashmir, Andaman & Nicobar Islands, Lakshadweep).

As per Para (9) of the Mission Guidelines, the committed CA will be released to the States/UTs in 3 instalments of 20:40:40. The 1st instalment of 20% of committed CA is to be released immediately upon the approval of the SAAPs by the Apex Committee. Accordingly, the 1st instalments of committed CA (20%) had been released to the States/UTs as and when their SAAPs were approved. The 2nd /3rd instalment of committed CA (40%) against all 3 SAAPs will be released upon achievement of certain benchmarks as mentioned below.

- i. Total SAAP size to be as per allocation. In case the cost of projects is above the allocation for a State/UT, the entire additional cost has to be borne by the concerned State/UT.
- ii. Utilisation of at least 75% of the amount already released by the Centre and State according to the funding pattern.
- iii. Utilization of at least 75% the State/ULB/Private Sector share.
- iv. Meeting the service level milestones as assured in the roadmap contained in the SAAPs and certified in the report of the Independent Review and Monitoring Agency (IRMA).
- v. Mobilizing the assured resources as given in the SAAP by the States/UTs.
- vi. Fulfilling any other conditions imposed by the SHPSC, IFD in this Ministry and the Apex Committee.

Any excess or shortfall in the 1st /2nd instalment released on the basis of estimated cost shall be adjusted while releasing the 2nd / 3rd instalment of CA which will be based on approved cost. The

approved cost is the appraised cost or the tendered cost of the project (whichever is less) and has to be taken into account by the SHPSC.

6. Funds released for A&OE in FY 2021-22 under AMRUT 1.0 and AMRUT 2.0.

In its 27th Meeting, Apex Committee granted ex-post facto approval to release a sum of Rs. 56.63 crore during FY 2020-21 and Rs. 15.1725 crore during FY 2021-22 for A&OE under

AMRUT. Thereafter, with the approval of Secretary (HUA) and fulfilling the criteria laid down under Mission Guidelines, Rs. 42.9025 crore has been released to 9 States/UTs in FY 2021-22 under AMRUT. AMRUT 2.0 has since been launched by Hon'ble Prime Minister on 01.10.2021. Thereafter, Rs. 528.20 crore has been released to 31 States/UTs with Legislature in FY 2021-22 under AMRUT 2.0 as mentioned below: -
