Minutes of the 23rd meeting of Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) held on 26.08.2019 under the Chairmanship of Secretary (HUA)

The Joint Secretary and National Mission Director welcomed Secretary, Housing and Urban Affairs, officers from State/ UT Governments and other participants. The list of participants is annexed.

JS&MD (AMRUT) outlined the agenda for the meeting and presented progress in project implementation. Thereafter, discussions on the agenda items were initiated as follows:

Agenda 1: Progress in implementation of AMRUT

Atal Mission for Rejuvenation and Urban Transformation (AMRUT) was launched by the Hon'ble Prime Minister in June, 2015. Against the total SAAPs of Rs.77,640 crore, Detailed Project Reports (DPRs) have been approved by the States/UTs for projects worth Rs.80,448 crore and DPRs for projects worth Rs.1,522 crore are yet to be approved. Some States/UTs have taken projects in excess of approved SAAPs for which, the entire additional cost will be borne by the respective State/UT.

Out of the approved DPRs of Rs.80,448 crore, contracts have been awarded for projects worth Rs.66,093 crore, including completed projects of Rs.4,725 crore. Further, for projects worth Rs.8,306 crore, Notice Inviting Tenders (NITs) have been issued and for remaining DPRs of Rs.6,049 crore, NITs are to be issued.

Discussion

Secretary, HUA directed all States/UTs to focus on fast-tracking of projects and ensure completion of projects by end of the Mission. Further, States like Uttar Pradesh, Punjab and Kerala discussed the issue of non- receipts of bids in tendering process for awarding water supply and sewerage projects and requested Ministry's support. Secretary requested concerned States/UTs to discuss and share suggestive measures with JS&MD (AMRUT) to facilitate Ministry's interventions.

Decision of Apex Committee:

The Apex Committee stated that the progress of the Mission may be expedited in all States/UTs.

Agenda 2: Review of SAAP-III of Assam pending for approval

Government of Assam has submitted that they have achieved the 4 milestones required for approval of SAAP-III. As regards the remaining mandatory condition of awarding contracts for projects costing at least 25% of the size of their SAAP-I (Rs. 188.16 crore), State has submitted that they had floated tender for Dibrugarh Water supply project under SAAP-I, but the rate quoted by the only bidder (after 3rd call) was abnormally higher than the estimated cost and was not acceptable. Therefore, it had been decided to re-tender the project with revised estimates. Meanwhile, the tender for Nagaon Water Supply under SAAP-II for Rs.211.86 crore was floated and Letter of Award (LoA) has been issued to successful bidder.



State has submitted that the milestone of award of contracts for at least 25% of SAAP-I may be considered as deemed achieved in view of already issued contracts for projects of SAAP-II costing Rs.216.76 crore (which is 99% of the approved size of SAAP-II i.e. Rs.218.67 crore). State has accordingly requested to accord formal approval for SAAP-III of Assam.

AMRUT Division has proposed to accept the request of State to accord approval of SAAP-III of Assam and consequent release of first instalment of Central Assistance (CA) against it.

Decision of Apex Committee:

The Apex committee accorded approval for release of 1st instalment of SAAP III as a special case to the State of Assam.

Agenda 3: Revision in approved SAAPs of Meghalaya for the entire Mission period

The Ministry has approved SAAPs I & II submitted by the State of Meghalaya and released 1st instalments (20%) of committed CA against it. In-principle approval to SAAP-III of Meghalaya was also granted. The details are as below:

Discussion:

State has taken approval of Rs. 57.40 crore from SHPSC for revised SAAP whereas their total SAAP size is Rs.80.14 crore. Also, State requested to provide in-principal approval for taking up water supply projects worth Rs.22.74 crore for which DPR is ready.

Decision of Apex Committee:

The Apex Committee accorded approval for the revised SAAP and in-principal approval of additional Rs.22.74 crore for water supply project subject to the condition that State shall submit SHPSC approval within 10 days.

Agenda 4. Modification in Para 4.4 & 10.1 of Mission guidelines of AMRUT

(A) Modification in Para 4.4 – addition of new clause related to funding of IEC activities related to Jal Shakti Abhiyan through A&OE funds of AMRUT

Ministry of Jal Shakti, Government of India has launched Jal Shakti Abhiyan (JSA) from 1st July to 30th November, 2019, under which water stressed cities have been selected across the States for taking up water restoration measures. MoHUA is also participating actively in the JSA, along with States/UTs/ULBs to convert it into a *Jan Andolan*, through involvement of all relevant stakeholders by undertaking awareness campaign among the citizens for water conservation.

It has therefore been decided to allow the States/UTs to utilize their allocated Administrative and Office Expenses (A&OE) funds under AMRUT for taking up Information, Education and Communication (IEC) activities to raise public awareness related to water conservation under JSA.

Accordingly, Para 4.4 of the AMRUT Guidelines has been modified with the approval of Hon'ble MoS (I/C), HUA to have the following addition:

Para 4.4 (ix)

(ix) The State can utilize funds for Information, Education and Communication (IEC) activities undertaken for water conservation measures under 'Jal Shakti Abhiyan' in the selected statutory towns for the purpose.

(B) Modification in Para 10.1 – Partial change in the functions of Apex Committee of AMRUT

As per Para 10.1 of the Mission guidelines, one of the functions of the Apex Committee is to – "Allocate and release funds to the States/UTs/Mission Directorate." However, in its 22nd meeting held on 16.05.2019, the Apex Committee had decided to delegate its power of approving release of 1st / 2nd / 3rd instalments of CA for implementation of projects under AMRUT to Secretary (HUA) in consultation with IFD (MoHUA).

Accordingly, Para 10.1 of the AMRUT Guidelines has been modified with the approval of Hon'ble MoS (I/C), HUA as described below:

Para 10.1 – New Text

The functions of the Apex Committee are:

ii. ~~Allocate and release funds to the States/UTs/Mission Directorate. Secretary (HUA), in consultation with IFD (MoHUA), will approve the release of 1st / 2nd / 3rd instalments of Central Assistance to the States/UTs/Mission Directorates for implementation of projects under AMRUT. Apex Committee may henceforth be apprised of such releases in its subsequent meetings.~~

Note: For the purpose of convenient understanding, the deleted text has been shown struck off and the added text as underlined.

Decision of Apex Committee:

The Apex Committee was apprised of the modifications in Para 4.4 & 10.1 of AMRUT Mission guidelines.

Agenda 5. Release of 2nd instalment of committed Central Assistance (CA) to 8 States/UTs (Chandigarh, Chhattisgarh, Gujarat, Haryana, Karnataka, Odisha, Rajasthan, Telangana, West Bengal) and 3rd instalment of CA to Odisha

- i. State of **Haryana** submitted their claim for release of second instalment of committed CA against **all 3 SAAPs** after meeting all conditions including submission of IRMA report. The claim was examined in consultation with IFD and Rs.289.71 crore has been released to Haryana with the approval of Secretary (HUA) as detailed below:

For the States/UT of **Chandigarh, Chhattisgarh, Gujarat, Karnataka and Rajasthan**, 25% of the eligible amount was withheld while releasing 2nd instalment of CA for all 3 SAAPs due to non-receipt of IRMA/Compliance reports. Now, these States/UT have submitted the IRMA report, Action Taken Report and the Compliance Report. The claims were re-examined in consultation with IFD following which, Rs. 5.35 crore, Rs. 145.67 crore, Rs.309.86 crore, Rs. 233.25 crore and Rs. 143.91 crore have been released respectively to these States/UT based on their revised eligibility for **2nd instalment of CA against all 3 SAAPs** as mentioned below:

- iii. The State of **Telangana** also submitted claim for release of **2nd instalment of CA against SAAP III** in addition to release of **withheld 25% of 2nd instalment of eligible CA against SAAPs I & II**. Complete funds against SAAPs - I & II could not be released earlier as State could not furnish the IRMA reports/Compliance reports then. However, the IRMA

reports/ATR/Compliance reports have been submitted later by the State. The claim was examined in consultation with IFD and eligible amount of Rs.178.82 crore has been released to the State with the approval of Secretary (HUA) against pending payment of SAAPs I & II and eligible amount of 2nd instalment of SAAP-III as shown below:

The State of **Odisha** had submitted their claim for release of **3rd instalment of CA** against SAAPs I, II & III along with the required IRMA reports, Action taken report and the Compliance certificate issued by IRMA. The claim was examined in consultation with IFD, wherein it was decided that 3rd instalment of eligible CA may be released to the State against **SAAPs I & II** only at present. Accordingly, Rs.181.06 crore has been released to the State with the approval of Secretary (HUA) as shown below:

Discussion

It has been observed that claims are pending from most of the States/UTs for want of complete IRMA report for all the projects. It has been decided that States/UTs can submit their claim for 2nd/3rd instalment of project funds, for the projects against which IRMA has submitted their report without waiting for the complete report of all the projects. Claim will be processed for release of funds (part payment) against the eligible projects for which IRMA has submitted their report.

Decision of Apex Committee:

The Apex Committee was apprised of the release of second instalment and third instalment of committed Central Assistance (CA) to aforesaid States.

The Apex Committee accorded approval for release of funds (part payment) against the eligible projects for which IRMA has submitted their report.

Agenda 6. Funds released for A&OE in 2019-20.

With the approval of Secretary (HUA) and after fulfilling the criteria laid down under Mission Guidelines, a sum of Rs. 74.775 crore has been released to 10 States for A&OE under AMRUT for FY 2019-20 as mentioned below:

Decision of Apex Committee:

The Apex Committee granted post-facto approval for release of funds for Reform incentive to aforesaid States for FY 2018-19.

Agenda 8. Grant of incentives for issuing Municipal Bonds in the FY 2019-20

AMRUT has a reform agenda which includes Credit Rating of the Urban Local Bodies (ULBs) and floating Municipal Bonds. Municipal Bond market has great potential of augmenting the financial capacity of the ULBs, and this Ministry therefore, during the FY 2018-19, incentivized 8 ULBs with Rs. 181.33 crore for issuance of Municipal Bonds.

In light of the requests received from the ULBs for providing financial incentive for issuing Municipal Bonds in the year 2019-20 also, it was decided by the Apex Committee in its 22nd meeting held on 16.05.2019, that the scheme may be continued in the current FY as well.

Accordingly, and with the approval of Hon'ble MoS (I/C), it has been decided to incentivize up to 12 ULBs on 'first come, first serve' principle for issuing Municipal Bonds during the current FY, i.e. 2019-20, based on the date of issue of Bonds. The incentive to each ULB will be limited to Rs. 26 crore @ Rs.13 crore per Rs.100 crore of Bonds issued. This will be met out of the funds allocated to reform incentive for the year 2019-20.

Decision of Apex Committee:

The Apex Committee was apprised of the continuation of granting of incentives in FY 2019-20 to (upto) 12 ULBs for issuing Municipal Bonds on first come first serve basis.

To encourage more ULBs to issue municipal bonds, it has been decided that incentive shall be given to a ULB only once.

Agenda 9. Release of funds for formulation of GIS based master-plan sub-scheme under AMRUT.

Since the 22nd meeting of Apex Committee held on 16.05.2019, further funds have been released to Jharkhand, Sikkim, Kerala and NRSC for implementation of GIS based master-plan sub-scheme under AMRUT as described below:

Decision of Apex Committee:

The Apex Committee granted post-facto approval for release of funds for formulation of GIS based master plan sub-scheme to aforesaid States.

Agenda 10. Funds released under A&OE of AMRUT for implementation of the sub-scheme Pilot on Formulation of Local Area Plan (LAP) and Town Planning Scheme (TPS).

Discussion:

Secretary, HUA requested all States/UTs to actively participate in capacity building programme being organised for LAP/TPS. The town planners may be trained on live/ongoing projects with handholding support from institutions like CEPT, TNUS. Subsequently, TPS may be independently taken up by all States/UTs. JS (AMRUT) pointed out that the preliminary proposals which requires SHPSC approval as per the LAP-TPS guidelines gets delayed due to delay in convening the SHPSC meeting.

Decision of Apex Committee:

The Apex Committee granted post-facto approval for release of funds for implementation of sub-scheme on “Pilot on formulation of Local Area Plan (LAP) and Town Planning (TPS)” to aforesaid States from A&OE funds under AMRUT.

For claiming funds for implementation of sub scheme, it has been decided that the preliminary proposals for the release of first instalment under LAP-TPS may be considered, if Principal Secretary (UD) of State gives the approval with an undertaking that the post-facto approval shall be obtained in the forthcoming SHPSC meeting as and when convened.

Actions to be taken by States/UTs:

Secretary, HUA appreciated the progress of AMRUT Mission and requested all States/UTs to ensure completion of projects by the end of the Mission period. He further informed that the extension of AMRUT Mission is under consideration.

Also, the Ministry is envisaging a new mission for water supply with more coordinated and integrated approach covering all urban local bodies on the lines of Jal Jeevan Mission. Further, 14 States/UTs made presentations on implementation progress under AMRUT Mission and following actions are to be taken by States/UTs in a time-bound manner.

I). TAMIL NADU

The State committed that they will complete all the projects within the Mission period. All the projects will be awarded by September, 2019.

II). NAGALAND

The State committed to complete all the projects by March, 2020. All the projects are to be awarded by October, 2019.

III). ARUNACHAL PRADESH

The State committed to complete all projects except sewerage projects by September, 2020 and sewerage project by December, 2020.

IV). SIKKIM

The State informed that all the projects will be awarded by October, 2019. All the projects will be completed by March, 2020.

V). TRIPURA

The State committed to complete all the projects by March, 2020.



VI). UTTARAKHAND

The State to award all projects by October, 2019 except one project in Nainital.

VII). DELHI

All projects to be awarded by October, 2019. The IRMA report to be submitted by 6 September, 2019 for release of funds.

VIII). GOA

The State informed that projects worth about Rs.100 crore could not be tendered due to the ongoing works of Coastal Zone Management Plan and public resistance. State to resolve the issue in discussion with relevant department and public consultation on priority basis.
