

**Minutes of the Eighth Meeting of the Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 held under the Chairmanship of Secretary (HUA) on 25.09.2023 from 02:00 PM to 03:00 PM**

The Additional Secretary and National Mission Director (AMRUT) welcomed Secretary (Housing and Urban Affairs), other Members of the Apex Committee and participating officers from State/ UT Governments.

She invited Director (AMRUT) to initiate the discussion on agenda of the meeting through detailed presentation on items of the agenda. The List of participants is at Annexure-A.

Discussion on the agenda was held in the meeting and its outcome and decision taken thereon by the Apex Committee is stated in following paragraphs.

**1. Review of progress in implementation of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) & AMRUT 2.0.**

**Director (AMRUT) briefed on the progress of AMRUT 2.0.** So far, projects worth ₹1,39,712.26 crore (incl. O&M) have been approved, against which DPRs have been approved worth ₹76,559.26 crore, of these projects worth ₹24,697 crore have been grounded including completed projects worth ₹248.81 crore.

**Discussion:** The Committee observed that preparation of DPRs and pace of implementation may be expedited. The grounding of projects needs to be fast tracked.

## **5. Delegation of powers to National Mission Director (AMRUT) to incur expenditure towards payment of miscellaneous expenses from budget head (2217-Establishment Head) from A&OE funds allocated to MoHUA under AMRUT 2.0**

For functioning of day-to-day activities in AMRUT division, funds are released from A&OE funds allocated under establishment heads of AMRUT. These activities includes organising workshops, Logistics expenses for technical experts, payment of hired personnel & vehicle on contract basis etc.

**Decision:** Apex Committee approved the proposal that National Mission Director (AMRUT) may be delegated the power to incur expenditure upto ₹ 7 lakh in each case, as per Delegation of Financial Power Rules, 1978, from budget head (2217-Establishment Head) from A&OE funds allocated under AMRUT 2.0, in consultation with IFD.

## **6. Revision in approved SWAP-1 of Kerala**

**Discussion:** 8 water supply projects worth ₹294.669 cr. approved in SWAP-1 of Kerala were found not feasible by the State. The same were replaced with 13 projects in same water supply sector worth ₹287.48 cr.

The 6<sup>th</sup> SHPSC of the State approved the same for submitting the proposal before Apex Committee for approval.

**Decision :** Apex committee **approved** the proposed revision in the SWAP-1 of Kerala.

## **7. Revision of approved cost of projects of Gujarat**

State of Gujarat has submitted that some of their projects has addition in components like smart elements and increase in scope of work in terms of treatment capacity/ distribution network and coverage. State has accordingly requested to revise their SWAP so as the approved cost of projects to increase from ₹4159.69 cr. to ₹4884.24 cr.

**Decision:** Apex committee noted the change in the approved cost of projects of State of Gujarat under AMRUT 1.0

## **8. Other observations**

Secretary, MoHUA, the Chairperson, Apex Committee emphasised that States like Haryana & Maharashtra may consider taking up projects for re-use of treated water especially for industrial purposes. It was stated that successful tertiary treatment plants in other states may be visited by the concerned officials in the respective states to appreciate the latest technologies
