### ORDER

The Mission Director, AMRUT, as per the letter read as 2nd paper above, has forwarded a proposal received from the Indian Institute for Human Settlements (IIHS), Bangalore regarding an International Immersion Visit to Paris from 3<sup>rd</sup> November to 8<sup>th</sup> November, 2025 under the Capacity Building Programme of MoHUA. The visit is aimed at understanding innovations and best practices in wastewater management, decentralized waste processing, and governance models in urban transformation. Paris has been offered a valuable case study for Kerala's urban transformation efforts. As per AMRUT guidelines, expenditure for such capacity-building programmes, including international immersion visits, is fully covered

under 100% Central Assistance. IIHS has earmarked a delegation of three members from the State Government of Kerala to participate in this visit. The Mission Director has requested approval for the State Government's delegation to lead and participate in the programme.
