### ORDER

As per paper read 1st above , all States have been directed to constitute a State Level Sanctioning Committee (SLSC) for Centrally Sponsored Schemes (CSS) to consider and approve projects under the Flexi Fund Component.

2. As per letter read 2nd above , The Executive Director, Suchitwa Mission has requested to constitute a State Level Sanctioning Committee (SLSC) for approving projects under the Flexi Component of SBM(G)/SBM(U).

3. It is noted that the common SLSC earlier functioning under the Planning & Economic Affairs Department does not exist at present. In order to ensure uniformity and to enable effective consideration and approval of projects under the Flexi Fund component of all Centrally Sponsored Schemes implemented through the Local Self Government Department, Government have decided to constitute a common State Level Sanctioning Committee (SLSC) for all such schemes under LSGD.

4. Accordingly, Government are pleased to constitute the State Level Sanctioning Committee (SLSC) with the following composition:
