ORDER

11th SHPSC has considered following three projects under PARK Sector for according Administrative Sanction;

- 1) Kattappana Municipality -AMRUT2.0- Kattappana Municipality Open Park.
- 2) Kollam Corporation - AMRUT 2.0- Development of a new Park near Kollam Beach.
- 3) Mavelikkara Municipality - AMRUT 2.0- Development of Green Space and parks near Vellorekulam in Ward No.11, Mavelikkara Municipality.

2. Based on the recommendations of the SLTC, the 11th SHPSC of AMRUT 2.0 has decided to approve the following projects in the Parks and Green Spaces Development sector, subject to the conditions mentioned below:

- Administrative Sanction for Kattappana Municipality- AMRUT2.0- Kattappana Municipality Open Park, for ₹.0.397 Crore (CAPEX: ₹ 0.367 Crore; OPEX: ₹ 0.03 Crore).
- Administrative Sanction for Kollam Corporation -AMRUT 2.0- Development of a new Park near Kollam Beach, for ₹.0.90 Crore (CAPEX: ₹ 0.75 Crore; OPEX: ₹ 0.15 Crore).
- Administrative Sanction for Mavelikkara Municipality-AMRUT 2.0- Development of Green Space and parks near Vellorekulam in Ward No.11, Mavelikkara Municipality, for ₹.0.488 Crore (CAPEX: ₹ 0.463 Crore; OPEX: ₹ 0.025 Crore)

- Central Assistance will cover only the Capital Expenditure (CAPEX) and will not extend to Operational & Maintenance (OPEX) costs or land acquisition expenses.
- Projects must serve the public interest and secure all necessary regulatory clearances before commencement.
- Any costs exceeding the allocated SWAP amount must be funded by the respective Urban Local Bodies (ULBs).
- ULBs should implement measures to ensure that Green Spaces and Parks are consistently clean and well-maintained.
- The Municipal Council's approval.
