ORDER

The 38th SHPSC of AMRUT has considered the proposal of the Kozhikkode Municipal Corporation for taking up of additional works under the Water Supply, Storm Water Drainage and Park sectors.

2. Based on the recommendations of the SLTC, subject to the conditions mentioned below, as per the minutes read as 1st paper above, 38th SHPSC of AMRUT has decided following.

Decision No. 38.4.6:

- Approved the taking up the following additional works (Total: ₹1.74 Cr., including the works in the Agenda Item No. 38.AA.1) under the WS sector work, 'Water Supply Scheme for Kozhikode Corporation', and the revision of its AS from ₹111.33 Cr. to ₹113.07 Cr.:
- Kozhikode Water Supply Project - extension of distribution network and providing FHTC in Ward-32 & 33 - general civil work: ₹0.74 Cr.
- Water Tanker (3 nos.): ₹1.00 Cr.

- The additional fund requirement (WS: ₹1.74 Cr., SWD: ₹1.60 Cr., Park: ₹0.50 Cr., Total: ₹3.84 Cr.) of the Kozhikode Corporation due to the taking up of the above-mentioned additional works shall be met from the balance amount available (₹1.288 Cr.) in the amounts claimed from MoHUA of the ULB, and the balance (₹2.552 Cr.) from the balance amount available in the amounts claimed from MoHUA of other ULBs under AMRUT-1.0.
- In case sufficient amount is not available at the time of final reconciliation, the amount required over and above the available amount shall be borne by the ULB.
- Any financial implications due to the non-completion of the works within the mission period shall be borne by the ULB.

3. As per the letter read as 2nd paper above, the Mission Director, AMRUT has requested to accord sanction based on decisions of 38th SHPSC read as 1st paper above.

4. Government have examined the matter in detail and are pleased to accord sanction to take up additional work under Water Supply, Storm Water Drainage and Park sectors of Kozhikkode Municipal Corporation and and revision of Administrative Sanction (AS) as follows, subject to the conditions mentioned below.

i. Additional works under the Water Supply Sector (WS), 'Water Supply Scheme for Kozhikode Corporation'. AS is revised from ₹111.33 Cr. to ₹113.07 Cr.:

- Kozhikode Water Supply Project - extension of distribution network and providing FHTC in Ward-32 & 33 - general civil work: ₹0.74 Cr.
- Water Tanker (3 nos.): ₹1.00 Cr.

ii. Additional work under the Storm Water Drainage (SWD) Sector, 'Construction of storm water drain at YMRC Road - Millathu Colony'. AS is revised from ₹9.382 Cr. to ₹10.982 Cr.:

- Floating Excavator (2 nos.): ₹1.60 Cr.

iii. Approval for taking up the following additional work under the Park Sector, 'Eravathkunnu Park (VK Krishna Menon Park). AS is revised from ₹1.31 Cr. to ₹1.50 Cr.:

- Bush Cutter (2 nos.): ₹0.50 Cr.
- The additional fund requirement (WS: ₹1.74 Cr., SWD: ₹1.60 Cr., Park: ₹0.50 Cr., Total: ₹3.84 Cr.) of the Kozhikode Corporation due to the taking up of the above-mentioned additional works shall be met from the balance amount available (₹1.288 Cr.) in the amounts claimed from MoHUA of the ULB, and the balance (₹2.552 Cr.) from the balance amount available in the amounts claimed from MoHUA of other ULBs under AMRUT-1.0.
- In case sufficient amount is not available at the time of final reconciliation, the amount required over and above the available amount shall be borne by the ULB.
- Any financial implications due to the non-completion of the works within the mission period shall be borne by the ULB.
