ORDER

As per G.O.read as 1st paper above, Government have constituted a Committee for conducting interviews and selection of professionals in the State Mission Management Unit (SMMU) and City Mission Management Units (CMMUs).

2. As per the letter read as 2nd paper above, the Mission Director has informed that notification for the vacant post of Urban Infrastructure cum Water Expert in certain City Mission Management Units (CMMUs) was published, and candidates have been shortlisted as per the prescribed qualifications and experiences required for the post and interviews were conducted at the office of the State Mission Management Unit (SMMU), Thycaud. Mission Director has reported that out of 26 candidates appeared for the interview, the following 8 candidates who scored more than 70% marks have been shortlisted in the order of merit:
