**ORDER**

As per letter read as 1<sup>st</sup> paper above, Ministry of Housing and Urban Affairs, GoI has informed that, in collaboration with National Institute of Securities Markets (NISM) is organizing a three-day intensive training programme combining conceptual learning with practical insights from market (credit rating agencies, stock exchanges, investment banks, senior practitioners with experience in municipal finance, etc.). The programme is being organised in 5 batches of 40 participants each (total 200 participants). The number of officials to be nominated from each State/UT is proportionate to the number of ULBs. Four officials from the State of Kerala are permitted to participate in the 4th batch of the training programme, scheduled from 18<sup>th</sup> to 20<sup>th</sup> March 2026. MoHUA has requested to nominate suitable officers from the State and also informed that the training fee, accommodation and food of the participants during training will be borne by the MoHUA. The travel expenses can be claimed by the participants from AMRUT 2.0 (A &OE) head of the respective States/UTs.
