As per the letter read as 1<sup>st</sup> paper above, Ministry of Housing & Urban Affairs, AMRUT Division, GoI has conveyed issue of Mother Sanction for an amount of Rs.3,35,00,000/- (Rupees Three Crore Thirty Five Lakhs only) to Govt. of Kerala, towards 50% of approved Central Assistance of Rs.6.70 Crore for Administrative and Other Expenses (A&OE) component under AMRUT 2.0 as 2nd installment for year 2025-26 through SNA SPARSH platform.

As per the letter read as 2<sup>nd</sup> paper above, the Mission Director, AMRUT has requested for Additional Authorization and release the following Budget Heads to receive Central Government Assistance (DDO CODE: 010467D053). Mission Director has also requested to accord sanction for the transfer credit of the amount to the Account of AMRUT 2.0 maintained by the Mission Director AMRUT with Account Number 7727206279 in Indian Bank, Thycaud Branch (IFS Code: IDIB000T021), towards recoupment of the expenditure already incurred from AMRUT Reform Incentive Fund 2024-25, consequent on the delay in release of funds from the MoHUA.
