As per G.O read as 1st paper above, Administrative Sanction has been accorded for the project of Construction of a bridge across the irrigation canal for the 100 KLD Septage Treatment Plant at Ramavarmapuram

As the Thrissur Municipal Corporation has decided to shift the location of the FSTP to the land vested with the IMA at Ramavarmmapuram from the originally proposed location near Snehavedu at Ramavarmmapuram, as per the decision read as 2nd paper above, the 12th SHPSC of AMRUT 2.0 has decided to cancel the work, Construction of a bridge across the irrigation canal for the 100 KLD Septage Treatment Plant at Ramavarmapuram, (Rs 0.36 Cr.), subject to the condition that any amount incurred for the work shall be borne by the ULB from its own fund.

3. As per the letter read as 3rd paper above, the Mission Director AMRUT has requested to accord sanction based on the above decision of 12th SHPSC of AMRUT 2.0

4. Government have examined the matter and are pleased to accord sanction to cancel the work, Construction of a bridge across the irrigation canal for the 100 KLD Septage Treatment Plant at Ramavarmapuram, (Rs

0.36 Cr.), subject to the condition that any amount incurred for the work shall be borne by the ULB from its own fund.
