**ORDER**

In accordance with the Mother Sanction from Government of India, as per the G.O read as 1<sup>st</sup> paper above, sanction was accorded for the release of an amount of Rs.275 Cr (Rupees Two Hundred and Seventy-Five Crore only), comprising Central Share of Rs. 125 crore and State Share of Rs. 150.00 crore. Subsequently, the Government of India revised the aforesaid Mother Sanction through re- appropriation, results in changes in the total amount to be allocated to Rs. 300 Cr (Central Share Rs.125 Cr and State Share Rs.175 Cr).

As per G.O read as 2<sup>nd</sup> paper above sanction has been accorded effecting the required re- appropriation for the release of Central Share received based on revised mother sanction and as per GO read as 3<sup>rd</sup> paper above, sanction has been accorded for the reallocation of an amount of Rs. 300 Cr (Rupees Three Hundred Crore Only) under SNA SPARSH, from the the budget head of State share to the Mission Director, AMRUT, the SCO of Major Head - 2217 with SCO Code- 67DL01, for the implementation of the projects approved under AMRUT 2.0 for 2025- 2026.
